

This license is a legally binding Agreement between the Subscriber and Building Systems Design, Inc., and it gives the Subscriber the right to use BSD CostLink/AE during the Term of the license or any mutually agreed-upon extension. By signing this Agreement, the Subscriber agrees to the following terms and conditions:

Definitions: " BSD CostLink/AE " means the cost estimating system that comprises a database of costs that is owned and copyrighted by R.S. Means and software that is owned and copyrighted by Building Systems Design, Inc. (BSD). BSD CostLink/AE also includes documentation and periodic newsletters copyrighted by BSD and the electronic CD-ROM media through which the database and software are delivered to the Subscriber. BSD CostLink/AE is a trademark and BSD CostLink is a registered trademark of Building Systems Design, Inc. "Term" means the one-year period after the BSD CostLink/AE subscription has been accepted by BSD. Term may be extended by mutual agreement between the Subscriber and BSD for additional one-year periods.

Subscriber's Rights: BSD grants the Subscriber the right to use BSD CostLink/AE during the Term in return for an annual license fee paid in advance. If the Subscriber is a company or other organization, anyone employed by or otherwise a member of the organization may use BSD CostLink/AE at the address indicated on this order form or at a subsequent address if the company or organization moves and has so notified BSD. BSD CostLink/AE may be used to produce cost estimates for specific projects and may not be used for other purposes. BSD CostLink/AE may be used on a network, provided that the number of concurrent users does not exceed the number permitted under the Subscriber's license. Estimates produced through the use of BSD CostLink/AE may be reproduced and distributed for use in connection with the particular project for which they were originally created. BSD and R.S. Means retain all other rights to BSD CostLink/AE not specifically granted in this Agreement.

Transfer of License: BSD's grant of use extends to members and employees of the Subscriber's organization only. The license is transferable to a different Subscriber upon agreement from BSD and after 1) sending a letter to BSD on Subscriber's letterhead stating desire to transfer license, 2) completing a Transfer of License form, 3) receiving an unsubscribe access key from BSD Technical Support and 4) paying a transfer fee.

Prohibitions: The Subscriber MAY NOT reproduce BSD CostLink/AE for the use of others or allow others who are not employees or members of the Subscriber's organization to access or otherwise make use of the copy of BSD CostLink/AE licensed by BSD to the Subscriber. The Subscriber MAY NOT decompile, reverse engineer, translate, decrypt, disassemble, or otherwise gain access to the underlying source code of the software or the R.S. Means databases for any purpose. The Subscriber MAY NOT reproduce, resell, publish, distribute, or otherwise make use of estimates produced through BSD CostLink/AE, except as permitted under "Subscriber's Rights" above. The Subscriber MAY NOT continue to use BSD CostLink/AE beyond the expiration of the Term, except by advance payment of an annual renewal license fee, which payment will extend the term automatically.

BSD's Obligations: BSD will distribute the newly updated R.S. Means database to the subscriber at or near the beginning of each calendar year. BSD will provide telephone support to Subscriber during normal office hours, which are 8:30 a.m. to 5:30 p.m., Eastern time, on normal business days.

THE SUBSCRIBER HEREBY ACKNOWLEDGES THAT SOFTWARE AND DATA ARE BOTH INHERENTLY SUBJECT TO ERROR AND THAT NEITHER BSD NOR ANYONE ELSE INVOLVED IN THE PREPARATION, REPRODUCTION, PROMOTION, OR DISTRIBUTION OF BSD COSTLINK/AE HAS MADE ANY REPRESENTATION OR WARRANTY, EXPRESS OR IMPLIED, OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE WITH RESPECT TO INFORMATION IN BSD COSTLINK/AE OR METHOD OF DELIVERY OF SUCH INFORMATION. In addition to and notwithstanding the above, in no event shall BSD or anyone else who has participated in the preparation, reproduction, promotion, or distribution of BSD CostLink/AE be liable for any consequential or special damages, or for any loss of profits incurred by the Subscriber or any third party in connection with or arising out of the use of BSD CostLink/AE.

Return Policy: If the Subscriber is not satisfied with BSD CostLink/AE for any reason, BSD will refund the full annual license fee, less a 15 percent service charge, upon return in good condition of all components of BSD CostLink/AE within 30 days of the subscription date, which is the date the subscription application has been accepted by BSD. In order to receive the refund, the subscriber must call Technical Support and receive an Unsubscribe Access key. The Subscriber must also send with the returned copy of BSD CostLink/AE a letter on the Subscriber's letterhead, explaining the reason for the return and certifying that no copies of BSD CostLink/AE have been retained. Components of BSD CostLink/AE damaged during shipment will be replaced without charge upon return of the damaged components.
